

## INVITATION FOR PROPOSAL

### World Music Festival 2022

The Municipality of Sines invites you to present a proposal for a show to be held at the 22th edition of the World Music Festival, under the following conditions and in compliance with the applicable legislation.

#### I - Contracting authority

The contracting entity, according to item c) no. 1 of article 2 of the CCP, is the Municipal Council of Sines, hereinafter referred to as CMS, NIPC 502 563 010, located at Largo Ramos da Costa, 7520-159 Sines, with telephone no. +351 269 630 600, fax no. +351 630 672, and e-mail address [info@mun-sines.pt](mailto:info@mun-sines.pt).

#### II - Decision to contract

Pursuant to paragraph 1 of article 36 of the CCP, in conjunction with paragraph 1 of article 18 of Decree-Law no. 197/99 of June 8, the decision to contract was adopted by order of the Vice-President of the Chamber in the use of his own competence, as provided for in Law no. 75/2013, of September 12.

#### III - The reasons for choosing the procedure

In accordance with the powers conferred by article 38 of the CCP, the procedure adopted by the CMS is the Direct Adjustment, in accordance with the provisions of paragraph a) of paragraph 1 of article 16 adopted according to the provisions of article 24, paragraph 1, subparagraph e), point i) of the CCP.

#### IV - Method and deadline for submission of the proposal

1. The proposal and other documents **must be sent by 6:00 pm on the 6th** day after the day following the sending of this invitation, by e-mail to [cpublica@mun-sines.pt](mailto:cpublica@mun-sines.pt);
2. The documents that constitute the proposal must be written in Portuguese or English, as provided for in no. 1 and 2 of article 58 of the CCP;
3. The tenderer shall sign the tender and all documents associated with it.

#### V - Base price

For the contract in question, the basic value is set at **€ 7.500,00 (seven thousand five hundred euros)**, which is the maximum price that CMS is willing to pay for the performance of all the services that constitute the object of the contract and functioning as the base price parameter contractual.

#### VI - Proposal documents

In accordance with the provisions of article 57 of the CCP, the proposal must consist of the following documents

- a) Declaration of acceptance of the contents of the specifications, in accordance with the model in Annex I of the CCP, in the wording given by Decree - Law no. 111 - B / 2017, of 31.08, which must be signed by the competitor or by a representative who has powers to bind and whose model is attached (Annex I);
- b) Document containing the attributes, terms and conditions in which the bidder proposes to contract (pursuant to points b) and c) of paragraph 1 of article 57 of the PCC).

#### **VII - Qualification documents**

- 1. The competitor must deliver within 5 working days after notification of the intention to award, the Declaration Annex II, provided for in paragraph a) of paragraph 1 of article 81 of the CCP, in the wording given by Decree-Law n (B), (d), (e) and (h) of paragraph 1 of Annex I, and the supporting documents that it is not in the situation referred to in paragraph 1 (b), (d), of article 55 of the CCP.
- 2. Pursuant to point c) of no. 1 of article 86 of the CCP, the qualification documents must be written in Portuguese or accompanied by a legalized translation.

#### **VIII - Applicable Legislation**

In all the omission in the present invitation will be observed the provisions of the Public Contracts Code approved by Decree-Law no. 18/2008, of 29.01, in its current wording.
